Message from Mayor John MacDonald:

On behalf of Council, I am pleased to present the 2012 Annual Report for the Village of Sayward for the reporting period January 1, 2012 to December 31, 2012. The Annual Report includes the 2012 audited financial statements and highlights of major Village initiatives and accomplishments. Through the commitment of Council and staff the Village continues to strive to meet and exceed the expectations of the residents of Sayward in the delivery of public services. It is my belief that we have made good progress over the last year but there is much more to be done.

Our CAO/CFO, Mr. Darren Kiedyk was hired on March 1, 2012 his positive relationship with staff, council and the village residents has been a welcomed change. He has a long range view for how he believes the municipality should be managed and also has a clear vision as to what he would like see accomplished in the village, such as upgrading the infrastructure, village beautification and a number economic initiatives. He and his staff strive to make Sayward a village that all of its citizens enjoy living in and are proud of.

The last year saw the formation of a new provincial group called the Mayor's Caucus. I attended the caucus meetings and brought forward the numerous fiscal and staffing inequities small communities are currently dealing with. One of the most difficult issues very small communities such as ours must deal with is competing with large municipalities for scarce infrastructure grants. The Mayor's caucus has asked me to put together a presentation to be given at the next meeting outlining the challenges we deal with on a daily basis.

Councillor Kirschner, the CAO and I attended the Union of British Columbia Municipalities convention in Victoria last September. We met with Premier Clarke, the Minister of Health, the Minister of Forests, Land and Natural Resources and staff from the Ministry of Transportation as well as the NDP Health critic. Several subjects of importance to the Village of Sayward were discussed with the Premier and Ministers such as infrastructure grants for small communities (bring back the Towns for Tomorrow grant program), the new water regulations being imposed by VIHA (Vancouver Island Health Authority) and the cost associated with complying with them, the critical need for medical staff in Sayward and various highway safety issues including the widening of the shoulders along highway 19, cell phone coverage and proper kilometer markers.

As members of this community you know too well that the local grocery store closed in 2012. Council and staff continue to work with the owner of the mall and any prospective investors who may be interested in opening a new business in the village by offering information and any assistance we are able to within the parameters of the community charter.

The grant received by Friends of Kelsey Centre was used to build the handicap access to the Village offices. In addition, the Village has received a number of small grants in the last year including a seniors grant, an infrastructure planning grant and a grant for the Kelly's bridge. Unfortunately the Village was not successful receiving a grant to upgrade

the Village's water system. Council and staff will continue to work with the VIHA on the upgrade to the village's water system. Grant applications will be again submitted in 2013 so that the Village can move forward with this project. In the meantime the water system continues to be monitored and tested on a daily basis.

Council wishes to recognize and thank the many volunteers who have done great work for the Village over the past year. These include activities such as sitting on Village committees, assisting with programs initiated by the Village, helping with various Village projects, painting murals in the Kelsey centre and in the countless other ways that have made our community such a great place to live.

Infrastructure improvements, service delivery, economic development and the livability of our community were high priorities for Council in 2012 and will remain so as we move through 2013 and beyond.
