Lee Ettinger	Why DCC's were not negotiated prior to the development start date for Mike Adama's development.	There is no DCC bylaw for the Village
Irene Callaghan	Asked why there was a secret meeting between the developer and the Mayor and CAO prior to Council finding out about it?	Developers usually require direction on the bylaws in place in the Village prior to submitting plans, this is a common practice and commitments are made
Unknown	Why were Villagers not properly informed of the blasts?	There is no requirement for the Village to be informed of blasting. When we next meet with WFP, we will ask that they advise us when blasting and Staff will get a note out to residents
Darryl Lyons	Was the missing recorder reported to the RCMP?	Cllr. Ives replied that the RCMP had a file on it
Lee Ettinger	Why was John France in the office when he is not an employee of the village?	Acting Mayor Norm Kirschner advised the Mr. France was here to help out with a technical matter. Mr. France was not remunerated for his advice
