Mayor – We are trying to move forward with the waterfront project and the revitalization of the wharf area, and a potential parking lot created at the ice plant area.
Bob Van Brocklin	Water is normally around \$200/metre. Are you extending the sewer line as well?	CAO – Prices have gone up and we need to make sure we have a contingency for all potential costs and unforeseen costs.
