I am writing today with an update on B.C.'s decriminalization of people who use drugs, and what this means for liquor licensees.

As you may know, B.C. is preparing to decriminalize the personal possession of small amounts of certain drugs. This means that starting **January 31, 2023**, adults will not be subject to criminal charges for the personal possession of small amounts of certain illegal drugs, and the drugs will not be seized. The decriminalization of people who possess illegal drugs for personal use is a critical step in B.C.'s fight against the toxic drug crisis. Further information is available at:

FAQ - Decriminalization

Overview

What does 'decriminalization' mean?

Health Canada has granted the Province of B.C. an exemption from s. 4(1) of the Controlled Drugs and Substances Act until January 31, 2026.

This means that starting January 31, 2023, adults in B.C. will not be subject to criminal charges for the personal possession of small amounts of certain illegal drugs.

The total amount of illegal drugs must be 2.5 grams or less. This includes opioids, crack and powder cocaine, methamphetamine and MDMA.

The trafficking of these drugs or the possession of quantities above theses limits remains illegal and subject to criminal charges.

This exemption from prosecution for possession does not mean that the possession of narcotics is permitted in all contexts or that the consumption of drugs cannot be regulated or controlled under other legal authority (including provincial legislation or municipal by-laws).

Why is B.C. decriminalizing the possession of certain illegal drugs?

The decriminalization of people who possess illegal drugs for personal use is a critical step in B.C.'s fight against the toxic drug crisis.

It will help reduce the barriers and stigma that prevent people from accessing lifesaving supports and services. Substance use is a public health matter, not a criminal justice issue.

Licensed Establishments

What does this mean for licensees?

As restaurants, bars and liquor manufacturers are private businesses, licensees retain the right to refuse service and set house rules governing their establishments. This includes prohibiting patrons from possessing or consuming any illegal drugs within their premises.

Further, the Liquor Control and Licensing Act continues to prohibit licensees from admitting intoxicated patrons, allowing patrons to become intoxicated, and allowing intoxicated patrons to remain in the licensed establishment. This includes intoxication from narcotics.

What if an individual is found using drugs on a business' property?

If a licensee observes drug use, the licensee may request that the individual(s) leave the premises. Additionally, police retain legal authority, under the Trespass Act, to remove people from these premises where the latter have not complied with an establishment's request that they leave. Public intoxication – whether by drugs or alcohol – remains illegal.

Under the Liquor Control and Licensing Act (LCLA), police may issue a ticket to a person who is intoxicated, including by the effect of illegal drugs, in a public place (which includes a bar or restaurant).

What resources are available if patrons possess/use illegal drugs?

If open drug use is occurring in an establishment or if unlawful activities are taking place, you may ask the person to cease the activity or to depart. If they do not comply, police can remove people from the establishment under the authority of the provincial Trespass Act.

Trespass laws allow licensees to refuse entry, or require patrons to leave their establishments, including when the licensee determines it is necessary to maintain the safe operation of the establishment and to comply with license terms and conditions.

However, adults who are removed by police and found in personal possession of illegal drugs that add up to a combined total of 2.5 grams or less will not be subject to criminal charges, and the drugs will not be seized. Instead, they will be offered information about health and social supports, including local treatment and recovery services, if requested.

Good Morning Mayor Baker and Councilors Burchett, Gilkin, Poulsen and Tinsley

These photos are an example of the approximate DB levels experienced property line vs living area. The first level was checked at the property line. The second shows the indoor DB values at the indoor wall of the neighbouring dwelling closest to the device. The third shows the offending device. Spoiler it is a heat pump my 80 plus year old neighbor uses to heat her home. It is not overly loud. It is very comparable to most other new heat pumps and is currently running at 50 + decibels at the property line. Indoors 12-15 feet and a poorly/ lightly insulated dwelling wall away from the unit it is half that at 25 db and barely noticeable. An amendment to 40 db at the property line would prohibit the use of many heat pumps at night (every night ,not just during the power outages). And if an exemption is made for heating units, as the Generator is used to power the heating unit in the case of a power outage it would likely be exempted as well and that is something the Village Lawyers would have to look into.



Good Morning Mayor Baker:

I am writing you with some thoughts on the proposed Bylaw amendment and why I consider it an incorrect course of action at this time. I understand the frustration centered around Power outages in this area as we all do . They are frustrating! Personally I don't need a Generator to power my house, we have a wood stove we can cook on and that provides heat. We stock lanterns and candles to use and know how to get the most from our appliances while they are unpowered (fridge, freezer, HW tank etc.). Unfortunately that is not the case for everyone though.

I grew up in Remote areas without Power for much of my life so it is not as much of an inconvenience in our house hold

I suffer from chronic pain from several bad Car accidents and understand the need for a good night sleep, which with pain you rarely get. I have done intensive programs for pain and medication management and have found a work life balance that works in my case. This does not mean the pain goes away merely that I live life with it.

Many others also suffer pain and disability and I recognize that some are much more severe than my case. Lam mobile

Many others also suffer pain and disability and I recognize that some are much more severe than my case, I am mobile, I have the ability to ration, to think and speak clearly and I can get in and out of my home in an emergency without undue stress because of a power outage. For some who would have to aid moving their spouse or who have mobility or functional issues this could be life or death if there were no lights, no stair lifts, no support machines etc.

Noise

In our micro neighborhood area (directly around 411 Macmillan) the recent average outside nightly Decibel readings are around 24 to 25 db this is fairly constant throughout the year on a regular basis.

When the wind blows hard it gets louder for a night or two, when it is Oscar days it gets significantly louder for a night or two and when the power goes out and the folks with auto start generators machines fire up it gets louder (more like the wind than the Partiers loud though). We are lucky this year to have had relatively few power outages compared to other years, and many of those were during the day so generator noise was really not an issue in regards to the Bylaw. I believe if you calculate our nightly environmental noise throughout the year even including the Loud nights for wind, generators, parties, fireworks etc. you will find Sayward is lucky to still be well under the WHO recommended Yearly average of 40db as (sort of) put through in the presentation to council. The WHO recommendations are just that an average over the entire year. Meaning the odd non conforming night is acceptable.

Costs/ vs Performance

A grid tie back up generator is an expensive proposition. Most are going to be around 10-15000 dollars plus another 3-5000 dollars for breaker boxes , rewiring , and installation (if you can get a tradesperson up here at the time). They are engineered to perform a certain way , they are predominantly air-cooled and need air flow to keep them cool . They need to stay within certain temperatures to maintain the life of the electronics that control them and make them function correctly . Heat destroys electronics and will greatly reduce the lifespan of the generator or device . Thus simply wrapping them in insulation blankets etc. is a short sighted and likely costly proposition. As is trying to turn a dry exhaust into a wet exhaust by running it through water . This creates a back pressure that will lead to increased build up in the engine, incorrect air fuel mixtures etc. on the mechanical side of things. PLUS these whole home Generators are designed for a tolerable sound level and already insulated and ventilated for optimal performance with minimal noise pollution. Adding the requirement that Generator produce a Maximum of 40 db at the property line when it is only a handful of nights when the power is out is overly restrictive on an already very costly install that for some is an absolute necessity.

Macmillan specific

Indoors my Db levels on an average night are about 15-20, my house is not overly well insulated, I would suggest it is about average for the village homes, often we sleep with our windows open and being directly across from our two neighbors, we are close and within direct soundwave paths of their Generators when they start up. When the Power goes out I usually wake up before the Generators of the village kick in. The entire house goes completely silent, the clock in the kitchen sounds like it was born of thunder and the animals stir. Then the Generators start to fire up, they return the ambient noise to the house and I go back to sleep. I dislike the power outage, I envy the folks with Power but I do not begrudge them the noise. I realize that most have an actual need for power and light and working appliances to care for their loved ones in the rare case the power is lost at night. And in the event of an actual emergency might be the difference between survivors and two causalities if one spouse can use a lift to help extricate their partner from the scene.

In Summary

The added cost / expense to sound proof Generators further seems punitive in this case.

Doing so incorrectly / cheaply may cause major damage to components.

The Yearly Average of 40 db for good sleep the WHO recommends is still applicable to Sayward even with the odd rowdy or loud night or portion there of.

The added expense will deter many (who may very much need a back up system) from being able to install one a

Sleep Quality measurements should be taken inside the home bedrooms, not at the property line and the cost of soundproofing personal sleeping quarters to meet individually desired DB levels in all circumstances where noise levels are within current bylaws should be the onus of the persons residing in that bedroom rather than their community.

Neighbors should approach one another to try to settle these disputes and work towards an amenable solution before involving the council.

We are not large a Urban Center, there are unique factors to living in an area like Sayward that are not experienced in the cities. Like power outages, a predominantly senior population, many of whom have medic alert/life alert systems which do not function in a power outage lasting any length of time. We also have a number of neighbors whos spouses have suffered serious medical issues and may be partially or fully disabled because of them.

If the Bylaw Passes I think a case can be made for Medical exemptions for physical impairment and disability or lack of cognitive function over persons fully mobile capable of clear thought and speech but suffering from other things

2023 Strategic and Financial Planning Process

Meeting date: February 7, 2023

BACKGROUND

At the January 31, 2023 Committee of the Whole meeting discussion was held regarding strategic planning options for Council and staff. Council expressed their preference for an in-house facilitated strategic planning process for 2022, and requested that staff report back with scheduling options.

DISCUSSION

As staff reported at the January 31, 2023 Committee of the Whole meeting, it is important that a strategic planning, or priority setting, process is integrated with the Village's financial planning process.

The CAO will lead Council and the senior leadership team through a review of the 2022 Strategic Plan, and make revisions, with the proviso that the revisions will be minor, i.e. removing and/or adding a small number of Priorities and Progress Measures. The Timelines for all the Priorities and Progress Measures will change, accordingly.

A schedule for 2023 financial planning has been planned in conjunction with Committee of the Whole (COW) meetings in February and March, albeit prior to consideration of a strategic planning schedule. Staff have reviewed the Committee of the Whole meeting schedule as well as the Council meeting schedule, in conjunction with the time required to develop and deliver these processes, and propose the following:

- Thursday February 9 2023: NEW MEETING; 10:00am-2:00pm Strategic Planning with Senior Leadership Team (staff only)
- February 14 2023: REVISED COW MEETING TIME; 1:00-7:00pm Strategic **Planning with Council**

- February 28 2023: **NEW COW MEETING**; 7:00pm: Strategic and Financial Planning with Council
- March 7 2023: CANCEL COUNCIL MEETING
- March 14 2023: COW MEETING; 7:00pm: Strategic and Financial Planning with Council

This schedule will allow Staff to present the Village's Financial Plan (5 year Operating and Capital budgets) to Council on April 4 for approval. Once these documents are approved, it will be recommended to Council that staff be directed to prepare the 2023-2027 Financial Plan Bylaw and the 2023 Tax Rates Bylaw for first, second, and third readings on April 18. Fourth and final reading of both bylaws will then take place on May 2, which will ensure adoption in time for the legislated May 15 deadline.

RECOMMENDATIONS

THAT Council receive the 2023 Strategic and Financial Planning Process report; and,

THAT the COW meeting scheduled for February 14th at 7:00pm be rescheduled to occur 1:00-7:00pm; and,

VILLAGE OF SAYWARD BYLAW NO. 493

A BYLAW TO PROVIDE FOR THE BORROWING OF MONEY IN ANTICIPATION OF REVENUE

WHEREAS the Village of Sayward may not have sufficient cash on hand to meet the current lawful expenditures of the municipality;

AND WHEREAS it is provided by Section 177 of the *Community Charter* that Council may, without the assent of the electors or the approval of the Inspector of Municipalities, provide for the borrowing of such sums of money as may be necessary to meet the current lawful expenditures of the municipality provided that the total of the outstanding liabilities does not exceed the sum of:

- a.) The whole amount remaining unpaid of the taxes for all purposes levied during the current year, provided that prior to the adoption of the annual property tax bylaw in any year, the amount of the taxes during the current year for this purpose shall be deemed to be 75% of the taxes levied for all purposes in the immediately preceding year; and
- b.) The whole amount of any sums of money remaining due from other governments;

AND WHEREAS there are no liabilities outstanding under Section 177;

AND WHEREAS the total amount of liability that Council may incur is seven hundred thousand dollars (\$700,000) made up of the sum of two hundred and eighty-five thousand dollars (\$285,000), being 75% of the whole amount of the taxes levied for all purposes in 2022, and four hundred and fifteen thousand dollars (\$415,000), being the whole amount of the sum of money remaining due from other governments;

NOW THEREFORE the Council of the Village of Sayward, in open meeting assembled, enacts as follows:

- 1. This bylaw may be cited as "Revenue Anticipation Bylaw No. 493, 2023".
- 2. The Council shall be and is hereby empowered and authorized to borrow upon the credit of the municipality an amount or amounts not exceeding the sum of seven hundred thousand dollars (\$700,000).
- 3. The form of obligation to be given as acknowledgement of the liability shall be a promissory note or notes bearing the corporate seal and signed by the Mayor and Financial Officer.
- 4. All unpaid taxes, the taxes of the current year when levied, and sums due from other governments or so much thereof as may be necessary shall, when collected, be used to repay the money so borrowed.

- 5. All the monies so borrowed and the interest payable theron shall be payable on or before the 31st day of December 2023.
- 6. If any section, subsection, sentence, clause or phrase of this bylaw is for any reason held to be invalid by the decision of any Court of competent jurisdiction, the decision shall not affect the validity of the remaining portions of this bylaw.
