It's been an eventful and busy February, and in this month's update I'm pleased to share some announcements that support people and invest in our communities here in the North Island, and across B.C.

I returned to the legislature this month for a new session of presenting, debating, and passing legislation alongside my colleagues. In our first week, we presented our Throne Speech and 2024 Budget, sharing some of the priorities of our government for the year ahead. We're focusing on the things that matter most to people, like housing, healthcare, the environment, public safety and the cost of living.

Some highlights include:

- Delivering more homes for people by launching BC Builds, while taking new action to protect renters from bad-faith evictions and help first-time homebuyers.
- Helping people and small businesses with costs, while tackling the root causes that make life more expensive.
- Strengthening public health care by continuing to attract more family doctors while investing new resources into cancer care and long-term care for seniors.
- Building an economy that works better for people by leveraging BC's strength in natural resources, and training people for the good clean jobs of today and tomorrow.
- Protecting BC from climate emergencies with year-round wildfire-fighting resources and new actions to reduce pollution from big industrial emitters.
- Keeping kids and communities safe by introducing new legislation to protect schools and kids from disruptive protests and to hold big social media companies accountable.

In the 2024 Budget, we're continuing to invest in people and the infrastructure and services we rely on. We're increasing the BC Family Benefit, helping more than 340,000 families every month, and for families wanting to grow, we're helping people access a free cycle of in-vitro fertilization, beginning next year. We're also helping people and businesses with their electricity bills, and providing record capital funding to support new needed infrastructure like schools, healthcare facilities, and housing. And we're bringing in a house flipping tax, so those who are bringing up

These are only some of the investments we're making for B.C. and in communities throughout B.C. There's more work to do, and me and my colleagues are ready to do it.

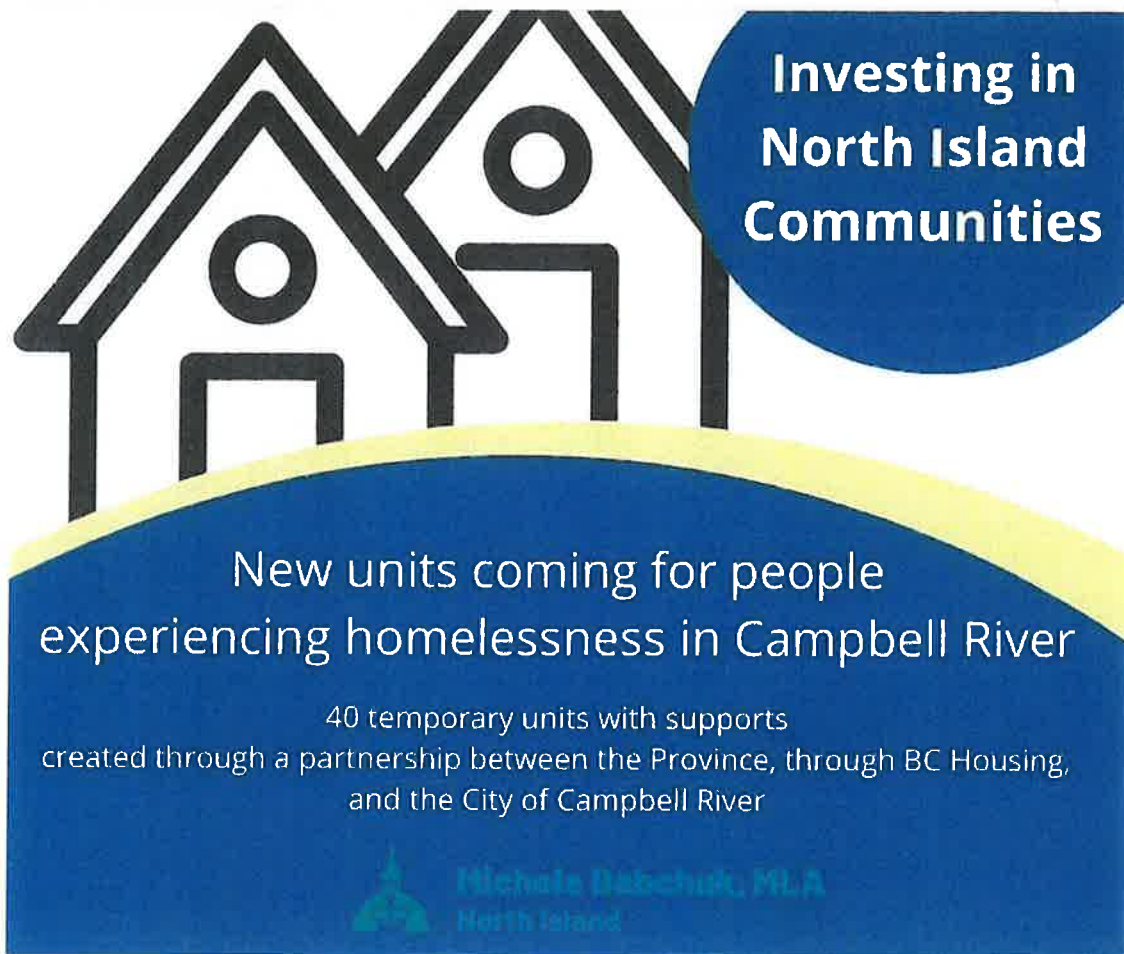

Our government is partnering with the City of Campbell River for the creation of HEARTH Village. This project is part of our government's Homeless Encampment Action Response Temporary Housing (HEARTH) program and is such a great step forward in supporting people to access safe, indoor shelter in Campbell River.

HEARTH Village was a concept started by the City of Campbell River and supported by the Table of Partners, which included the Downtown Campbell River Business Improvement Association and service providers. The Province, through BC Housing, is providing capital costs and funding, which is currently being determined. The City of Campbell River is providing the land for the project, as well as funding the civil works and site preparation costs. The Minister of Mental Health and Addictions, Hon. Jennifer Whiteside, along with community members, were instrumental in making this important project happen in Campbell River.

It was wonderful to tour regions of the North Island with Minister of Public Safety and Solicitor General, Mike Farnworth.

We were able to meet with Mayors and Councils from the City of Campbell River, the Town of Port McNeill, and the District of Port Hardy. We also met with the Wei Wai Kum First Nation, North Island Crisis and Counselling Centre Society, RCMP Detachments, and members of the Campbell River Downtown BIA and local service providers. There were great discussions all around about public safety and how we can continue to support communities in the North Island.



The Port Hardy Situation Table will launch this month and is made up of 14 community partners and agencies, including representatives from public safety, education, health care, and social and Indigenous services. The Province is supporting the Port Hardy Table with a \$60,000 grant to assist with implementation.

### BACKGROUND

To consider utilizing the Village's Indigenous Engagement Requirement (IER) grant funds in collaboration with the Strathcona Regional District, other municipalities and First Nations to staff a multi-year regional SRD Emergency Services Indigenous Engagement Coordinator staff position.

### DISCUSSION

The *Emergency and Disaster Management Act*, which obtained Royal Assent in November 2024, includes Indigenous engagement requirements that promote relationship building across jurisdictions and the incorporation of Indigenous knowledge and cultural safety across emergency management practices. The intent is to respect the inherent rights of Indigenous Peoples, enhance the emergency management outcomes for the safety of all, provide for policy improvements that reflect lived experience, and address the disproportionate impacts on Indigenous peoples during emergency events. Regulated entities as defined in EDMA are required to engage through emergency management, and local authorities (regional districts and municipalities) are required to consult and cooperate with Indigenous governing bodies through response and recovery.

The Village of Sayward has automatically received \$40,000 through the IER grant funding. If the Village were to use this one-time funding to pursue its own project the funds must be used by March 2025.

Recognizing these new regulatory requirements under EDMA requires a long-term strategic approach and extra personnel capacity, the Strathcona Regional District has convinced the Ministry of Emergency Management & Climate Readiness (EMCR) that Regional District's can receive the IER grant from their member municipalities and First Nations to fund a multi-year regional staff position "Emergency Program Indigenous Engagement Coordinator" (working title) whose job description would be to work on the bullet points identified in the funding guide over many years. Rather than each community using their funding for a one-off project before March 2025 this proposed approach increases bandwidth at a regional level to take a long-term strategic approach to the Indigenous engagement requirements under EDMA.

The goal Emergency Services Indigenous Engagement Coordinator's job description would be to implement the following new Indigenous Engagement Requirements under EDMA.

#### Reconciliation and Capacity Building

- Activities that support local reconciliation efforts such as meetings, engagements, and training, including building understanding of cultural safety and the integration of Indigenous knowledge in emergency management.
- Activities that enable self-determination, and governance of emergency management programs and services.
- Planning for and delivering cultural safety and humility training to local emergency management staff and volunteers.
- Activities that support First Nations establishing an Indigenous governing body for purposes of emergency management.

#### Agreement Building

- Assists with developing formal agreements about communications protocols that help local authorities understand which entities to consult, engage, coordinate, and cooperate with, when and how, through any or all phases of emergency management.
- Meeting to review the effectiveness of agreements.

#### Consultation and Cooperation

- Activities where local authorities contact or engage with Indigenous governing bodies and "make reasonable efforts to reach agreement on the areas to be described in local authority emergency management plans for the purposes of consultation and cooperation" under s.120 of EDMA.
- Engagements to discuss, confirm and document communication protocols that help local authorities understand which entities to consult, engage, coordinate, and cooperate with, when and how, through any or all phases of emergency management.

#### Relationship Building

- Activities that strengthen and develop relationships between Indigenous governing bodies and local authorities, and support collaboration in emergency management.
- Collaboratively developed or delivered training and preparedness initiatives, to support shared understanding of respective emergency management practices.

#### Planning

- Activities that support collaboration in developing emergency management plans and/or risk assessments; for example, engagements to explore how to incorporate cultural safety

and Indigenous knowledge, or how to identify and reduce disproportionate impacts in plans and/or risk assessments.

- Activities related to meeting consultation and cooperation requirements related to preparing, reviewing, and revising risk assessments or emergency management plans.

#### **RECOMMENDATION**

1. THAT Council receive the Regional Collaboration Opportunity - Indigenous Engagement Requirements staff for information and discussion; and,
2.
